

Motus Sub-processors

Overview

As provided in the Motus Privacy Notice and/or your Data Processing Agreement with Motus, LLC ("Motus"), Motus uses certain third-party service providers or subcontractors to assist it in providing its services to its clients and, specifically, to process personal data belonging to its clients on behalf of Motus ("Sub-processors").

What is a Sub-processor

A Sub-processor is a third-party data processor engaged by Motus, who has or potentially will have access to or process Users' (as defined in the Motus Privacy Notice) information or data, which may contain personal data. Motus engages different types of Sub-processors to perform various functions as explained in the tables below. These tables present an up to date list of Motus' Sub-processors, as of the date provided at the end of this document.

Sub-processor Due Dilligence

Motus undertakes commercially reasonable selection process by which it evaluates security, privacy and confidentiality practices of proposed subprocessors that will or may have access to or process.
